Aryan Foundation Nepal, Kathmandu, Nepal; a Government registered company incorporated in 2006 with objective of providing consultancy service to Nepalese students and helping them in getting admission for higher education into Institution / Universities Abroad, having its corporate office at Ground floor, Jaycees Bhawan, Thapathali, Kathmandu, Nepal of Second Part.

Hereinafter referred to as AFN

Now these present witnesses and it is hereby agreed and declared by and between the parties hereto as follows:-

#### **OBLIGATION OF AFN**

- To focus on the admission of Nepalese students in various courses offered at SRKR COLLEGE.
- AFN will promote SR KR COLLEGE in Nepal from AFN and its sister Concern organizations (WRC Kathmandu, WRC Janakpur and WRC Biratnagar) and other associates in Nepal.



- To promote SRKR COLLEGE in Nepal and generate awareness about SRKR COLLEGE and its courses among prospective students, parents and clients and provide required information and necessary support.
- Provide logistic support to SRKR COLLEGE in conducting seminar, exhibition and promotion in Nepal.
- Distribute the promotional material supplied by SRKR COLLEGE.
- Advice SRKR COLLEGE in participation in suitable promotional events.
- Release advertisement in appropriate media with mutual understanding and prior approval from SRKR COLLEGE about the advertisement.
- To screen the suitable candidate for admission to SRKR COLLEGE campuses and verify their documents as per the eligibility criteria provided by SRKR COLLEGE.
- To liaise between students and SRKR COLLEGE in all the matters relating to admissions if required.
- To collect the required fee for admission as prescribed by SRKR COLLEGE in the form of Demand Draft or RTGS and send the same to SRKR COLLEGE office.
- AFN will provide genuine and authentic information about SRKR College to students and its associates.
- AFN will tie up with +2 schools, Colleges, Faculties, Coaching Institutions and other consultants and agents in Nepal to generate maximum admission into SRKR College.

#### **Obligation of SRKR COLLEGE**

- To provide all the necessary support and training to the staff of AFN if required in no cost.
- To provide to AFN, all the necessary information relating to admission, eligibility, cost of living and tuition & other fee required for admission into various courses offered by SRKR COLLEGE.

- To keep the record of all application forwarded by AFN and its associates for admission into SRKR COLLEGE.

- SRKR College will fix a package for Nepal students for each course offered at SRKR

The University of Applied Sciences Upper Austria and the Sagi Ramakrishnam Raju Engineering College, in recognition of their common interests in developing bilateral relations and convinced that cooperation between institutes of higher education contributes to cultural enrichment, scientific progress, and the consolidation of friendship between countries, agree to establish the following Memorandum of Understanding.

#### 1. Student Exchange

Each year, the universities may exchange up to five full-time undergraduate or graduate students for one or two semesters of study and research at the host university.

#### 2. Selection of Students

Both universities shall select exchange students in accordance with criteria and procedures established by the home institution. The host university will reserve the right of making final judgement on the admission of each student nominated.

#### 3. Academic programme

Exchange students will be permitted to enrol in courses or programmes at the host institution for which they are qualified. The host university will provide information on the courses and programmes relevant to the students' studies and will assist the students in designing a study programme suited to their needs. Each institution shall provide a Transcript of Records of these courses and the grades achieved by the exchange student.

#### 4. Student status

Exchange Students will be entitled to all privileges and facilities, and are subject to the same rules and regulations as all other students. All exchange students must abide by the laws of the host country.

#### 5. Application

Each university shall nominate their students to be sent to the other university at least 5 months prior to the beginning of the respective semester. The students shall follow the application process outlined by the host university. Acceptance decisions will be made within one month.

#### 6. Financial Arrangements

Exchange students will be exempt from the payment of tuition fees at the host institution. All other costs, including travel, accommodation, health insurance and living expenses are the responsibility of the exchange student. The host university shall assist exchange students to find suitable housing, the cost of which shall be borne by the student.

#### 7. Visa Arrangements

Each exchange student is responsible for obtaining a visa and other related documents required for the stay at the host institution. The host university shall provide incoming exchange students with the university certification required to obtain a student visa for the full period of the exchange.

#### 8. Health Insurance

Each exchange student must carry adequate health insurance for the full period of the exchange.

#### 9. Staff exchange

In respect of exchanges or visits by members of their staff, the two universities will:

- a. agree in advance the teaching and other work to be undertaken by the visiting member,
- continue to pay the statutory salary to their own member of staff for the period of the exchange or visit according to the prevailing conditions of contract,
- c. be responsible for, according to its normal practices, the cost of travel between the two universities for their own staff,
- d. agree that the host university will do its best to arrange accommodation and provide assistance for the visiting member of staff.

## 10. Research Projects

Both universities shall examine the possibilities of joint research projects in areas where their interests correspond. Further details about the respective projects shall be determined in a separate mutual agreement.

## 11. On-Going Administration of this Agreement

This agreement shall be effective starting with the date of the last signature and shall continue for five academic years in the first instance. The terms of this agreement may be amended at any time by mutual written consent of the parties. This agreement may be terminated by either university by giving written notice to the other university 6 months in advance.

#### MEMORANDUM OF UNDERSTANDING FOR STUDENT EXCHANGE

In order to implement exchange programs based on agreement of cooperation between Jeju National University, Jeju in the Republic of Korea and Sagi Rama Krishnam Raju Engineering College in India the designated officials responsible for program administration mutually agree that:

- 1. Each university will recommend 3 exchange students in a year in undergraduate programs.
- 2. The home university will provide the host university with completed application forms. The students must have sufficient language proficiency required by the host university. And the host university may decide to accept the applicants or not.
- 3. Exchange students must be enrolled as full-time students of credit courses at their home university.

- 5. Exchange students are required to obtain health insurance during the period of exchange to provide proof to the host university.
- 6. Exchange students may live on campus housing, and need to complete the room and board license contract, and submit the contract to host institution in a timely fashion, and exchange students are responsible for the accommodation cost.
- 7. The host university will evaluate and grade academic performance of exchange or study abroad students, and send official transcripts to their home university.
- 8. The exchange period is up to one year. Both participants reserve the right to discontinue the study term of exchange students at any time for violation of their rules and regulations.
- 9. The memorandum may be revised or modified through jointly discussion and consent between the two sides. This arrangement becomes effective until five years from the date of signatures of two signatories. The period may be terminated by one of the signatories upon written notice to the other party no later than six months before the termination date.

And Dr.G.P.Saradbi Vama, Principal of the Sagi Rama Krishnam Raju Engineering College on behalf of the institution above,

#### **CONCLUDE**

#### **FIRST**

That the University of Jaen and Sagi Rama Krishnam Raju Engineering College agree on the establishment of a teaching/research staff and student exchange program (hereinafter Exchange) subject to the provisions of this Agreement.

#### **\$ECOND**

That collaboration and exchange of experiences and knowledge, as well as the growing relations between the two institutions are of best interest for the social and cultural progress of the aforement oned parties.

#### THIRD

That according to the provisions of Organic Law 15/1999 of December 13th on the Protection of Personal Lata, the data provided in this Agreement will be included in a computerized file duly registered at the Spanish Data Protection Agency with the name "Management of Information Service and General Affairs" belonging to the University of Jaén with the aim of providing means for an "Archive for documentary records of general documents, agreements, e-administration and complains and suggestions"

#### **FOURTH**







That in accordance with the provisions of current regulation on transparency, access to public information and good governance, this agreement and the data that of might be made public and accessible on the websites of the University of Jaén with the aim of tending to public interest that is the disclosure of information and the necessity of proper provision of service.

Therefore, both parties agree on the establishment of a specific collaboration agreement between the two institutions to be developed based on the provisions of the following part.

#### **FIRST**

#### **DEFINITIONS OF THE EXCHANGE PROGRAM**

In this Addendum to the General Agreement of Cooperation:

- (a) *Home University* means the University from which a student intends to graduate or the University, which is the regular employer of the participating teaching staff within the framework of the Exchange Program.
- (b) Host University means the University, which has agreed to host the participants within the framework of the Exchange Program.

#### **SECOND**

#### TERMS FOR THE TEACHING/RESEARCH STAFF EXCHANGE PROGRAM

Teaching/research staff exchange may be negotiated by either Party according to the appropriate institutional procedures (including relevant collective agreements and insurance requirements).

The number, timing and duration of the teaching/research staff exchange mobility may vary according to the needs of each particular proposal.

Reasonable efforts will be made to involve equal numbers of teaching/research staff members from UJA and SRKREC over the validity period of this Addendum.

#### **THIRD**

#### FINANCIAL RESPONSIBILITIES OF THE TEACHING/RESEARCH STAFF

The Host University will not bear any financial responsibility for visiting teaching/research staff, except as may be arranged and explicitly documented for specific cases.







Participating exchange teaching/research staff will submit a report on the experience to both parties upon completion.

The Host University will make reasonable efforts to provide information and advice regarding matters which may enhance the exchange experience for the participating teaching staff, such as campus facilities, housing options, and visa requirements.

## FOURTH TERMS FOR THE STUDENT EXCHANGE PROGRAM

The Exchange Program will be open to both undergraduate and graduate students.

Each Party will appoint a Coordinator responsible for the development and conduct of the Exchange Program.

Exchange Program candidates will be selected by the Home University and will be admitted by the Host University according to their standard procedures. In addition:

Exchange students will remain registered at their Home University throughout the period of their exchange.

Exchange students will be expected to meet the proficiency level of the host country language as requested by the Host University (and, accordingly, the Home University will be responsible for carrying out any language examination for this purpose prior to the beginning of the exchange period).

The exchange students' proposed program of studies at the Host University must be approved by both the Home University and the Host University prior to the exchange period.

Exchange students will be free to choose courses from the full range of undergraduate and graduate programs available at the Host University (as long as these incoming students meet the individual program prerequisites and space is available).

Participation in the Exchange Program will not give students any preference or special status when subsequently registering for a degree program at the Host University (once completed the exchange period abroad within the framework of this Addendum).







Exchange students will register as full-time students at the Host University for either one semester (fall or spring) or a maximum of one full academic year (fall and spring semesters):

- (a) The academic year at UJA is divided into two semesters: early September to late January (Semester 1) and late January to mid-June (Semester 2), with no academic activity during August.
- (b) The academic year at SRKREC is divided into two semesters: mid June to late November (Semester 1) and mid December till mid May (Semester 2).

Exchange students will not pay any tuition, institutional, application or enrolment fees at the Host University. Exchange Program students will only pay tuition, institutional, application and/or enrolment fees at their Home University.

During the first year, the number of exchange students participating in this Exchange Program will not exceed 5 (number) candidates from each University per academic year (or the equivalent number of semester students). However, the number of the participating exchange students may be increased by mutual agreement of the parties.

Both parties will review the Exchange Program on a regular basis for any imbalances in the number of students exchanged and will adjust the numbers as necessary to maintain a well-balanced program. Should one University send no exchange student at all in any one academic year, the other University will still be allowed to send at least one (1) exchange student (for either a semester or a full academic year stay).

#### FIFTH

#### FINANCIAL RESPONSIBILITIES FOR EXCHANGE STUDENTS

Financial responsibility for exchange students will be based on the following:

The Host University will not bear any financial responsibility for incoming exchange students except as may be arranged and explicitly documented for specific cases.

Exchange students will be obliged to obtain adequate travel, health, sickness, accident (repatriation) and civil liability insurance coverage as requested by the Host University.

Students will be expected to pay for all personal expenses, including (but not limited to) travel, transportation, accommodation, meals, books, visas, insurance and entertainment.

Where UJA and SRKREC graduate students are involved in PhD Thesis research, the parties will determine ownership of intellectual property (at the outset of the research project).

(At the end of each semester or academic year (or upon request), the Host University will send to the Home University an official transcript of the academic achievement of each exchange student.

The Host University will assist students in locating suitable accommodation, will offer campus orientation, and will provide advice regarding matters which may support and enhance the Exchange Program.

## SIXTH LEGAL PROVISIONS AND DISPUTE SETTLEMENT

Exchange Program participants will be bound by the rules and regulations of the Host University and the laws of the host country while on the Exchange Program.

Any dispute arising under the terms of this Addendum (which cannot be resolved by the parties) will be referred to an independent mediator approved by both parties.

#### SEVENTH

#### CONDITIONS OF MODIFICATION OF THE AGREEMENT

The modification of the content of this Agreement will require the unanimous consent of the signatory parties.

## EIGHTH VALIDITY PERIOD

It is understood that this Addendum will come into effect after being signed by both parties and will be established for a period of a year. After this first year it will be automatically extended for the same period up to a total of four years, unless one of the parties expresses an intention (by written notification) to cancel the agreement at least (3) three months before the expiry date.







Before the end of the four year period from the signing of the this Agreement the signatory parties may unanimously agree on its extension for a period of up to four addition years

Nevertheless, it is agreed that all the teaching staff and/or students participating in this Exchange Program (at the time of notice of termination) will be allowed to complete their academic year at the Host University under the terms of this Addendum.

This Addendum to the General Agreement of Cooperation is hereby put into effect and signed in duplicate (for an only purpose) at the place and on the date below written.

The areas of cooperation will include any program offered at either university which is felt to be desirable and feasible for the development and strengthening of cooperative relationships between the two institutions. However, any specific program shall be subject to mutual consent, availability of funds, and approval of each party. Such programs may include:

- a. Exchange of teachers, researchers, technical and administrative staff
- b. Exchange of undergraduate, graduate, doctoral and post-doctoral students
- c. Joint research projects
- d. Joint conferences
- e. Joint cultural programs
- f. Exchange of academic materials, publications, and other documentation.

The terms of such mutual assistance and cooperation shall be discussed and agreed upon in writing by the appropriate responsible officers of both parties prior to the initiation of any particular program or activity.

The validity of this agreement is subject to the conditions and recommendations of the academic approval process of both parties being satisfied; its terms may be amended at any time by mutual written consent of both parties.

The present agreement will come into force following the date of the last signature and will have a term of 5 years.

The agreement may be renewed for further periods by mutual written consent of the parties; however, after the initial period either party may terminate the agreement by giving six months notice in writing of such intent. The parties agree to solve in a friendly manner any controversy rising from the interpretation of the present agreement.

WHEREAS, Academy organizes various programmes to improve the quality of teaching, quality of education in the areas of Computer Science & Engineering, Information Technology, Electronics & Communication Engineering and other allied areas and Beneficiary Unit wishes send its faculty/personnel to attend Faculty Development Programmes with the aim to improve their quality of teaching and also the quality of education they impart through their academic programmes to the students enrolled in.

NOW THEREFORE, the Beneficiary Unit agrees to the following terms and conditions of the Academy and shall sign this Agreement, in acceptance of the terms and conditions of the Academy as set out hereunder.

#### 1.GRANT OF PERMISSION.

Subject to the terms and conditions of the Agreement, Academy grants to the Beneficiary Unit, a non-exclusive, non-transferable number of seats, to participate in the Faculty Development Programmes (FDPs) to be offered during one year from the effective date of this agreement. Beneficiary Unit can send any number of participants subject to total number of seats consumed in a year from the effective date is within the limit of its granted number of seats. All such participants sent by Beneficiary Unit need not pay registration fee prescribed for those FDPs and can avail all the benefits offered by the coordinator of FDP to any other participant who pay registration fee as individuals. Beneficiary Unit can send a faculty/person to attend any number of FDPs, but however each time that a faculty/person attending a FDP will be counted as a seat consumed by Beneficiary Unit. However, it cannot transfer its granted seats to any other institute/college/University or even to any other college/institute/university of their own management/administration located at a place different from the address of the Beneficiary Unit. In case, Beneficiary Unit is a member of group of institutions or in chain of institutions owned by same Management/administration and that Management/administration is interested to extend the benefits to their other institutes located at different locations, each such institute should sign an agreement with the academy. Here, the "institutes located at different locations" means the institutes set up at different towns/cities/villages. However, two or more institutes owned by the same management/administration and located in the same town/city/village will be treated as a Beneficiary Unit. Total number of seats granted to a Beneficiary Unit will be lapsed on 366th day from the effective date of this agreement and any number of seats unutilized by Beneficiary Unit will be not be carried over to the next year. Beneficiary Unit can send their faculty/personnel to a FDP if its starting date of FDP is within 365 days from the effective date.

#### 2. CONSIDERATION

- a. Beneficiary Unit should have paid the Annual Fee.
- b. Annual fee is fixed as follows for a year from the effective date and it includes registration fee to be paid by the participants from that Beneficiary Unit subject to total number of seats benefitted in a year from the effective date is within the limit of its granted number of seats.

However, any Faculty Development Programme (FDP) organized at an institute/college/university by E&ICT-NITW at any location other than NIT-Warangal will be joint programme of that institute/college/university as host institute and of E&ICT-NITW subject to E&ICT academy's terms and conditions which are in no way related to this agreement. Beneficiary Unit is welcome to come forward to organize such FDPs as host institute and it is independent of this agreement.

#### 5. PROPRIETARY RIGHTS

Beneficiary Unit is cognizant that E&ICT-NITW regards itsFaculty Development Programs (FDPs) as its proprietary activities and as confidential trade secrets of great value. The University of Colima, Mexico, hereinafter "U DE C" and Sagi Rama Krishnam Raju Engineering College, India, hereinafter referred to as "the Parties";

AIMED by the desire to strengthen their of friendship and cooperation bonds;

**INTERESTED** in promoting the development of specific agreements of educational and cultural cooperation;

**AWARE** of the importance of sharing experiences that contribute to the strengthening of activities in education;

#### Have agreed as follows:

## ARTICLE 1 Objetive

This Agreement aims to establish the basis by which the Parties, conduct cooperative activities in education, in identified areas of common interest.

## ARTICLE 2 Cooperation Areas

To achieve the objective referred to in Article 1, the Parties shall carry out cooperative activities in the following areas:

- a) Computer Science and Engineering
- b) Information Technology
- c) Mechanical Engineering
- d) Civil Engineering
- e) Electronics Engineering
- f) Electrical Engineering

## ARTICLE 3 Cooperation Modalities

In order to achieve the objective of this Agreement, the Parties may undertake cooperation activities without limitation through the following modalities:

- a) carrying out programs of basic and specialized courses, including courses at a distance and by electronic means;
- b) exchange of information, publications, videos and literature; and teaching material;
- c) exchange of experiences on the organization of education;
- d) exchange of faculty and students;
- e) planning joint activities;

- f) participate in scientific research projects;
- g) organizing cultural events and academic programs that can contribute to the enrichment and expansion in the educational understanding and experience of students, faculty and staff;
- h) any other agreed by the Parties.

The operation of this Agreement shall not be conditioned upon the parties launching projects for every field and cooperation form referred to in this Article.

The Parties shall not be obliged to cooperate in those activities for which there is an internal prohibition or a prohibition deriving from a law, an institutional policy or custom.

## ARTICLE 4 Annual Operational Programs

The Parties shall formulate Annual Operational Programs (AOP's) consisting of activities or projects to be developed which will be formalized once part of this Agreement. Each AOP must specify the following:

- a) objectives;
- b) execution schedule;
- c) allocation of human and material resources;
- d) financing;
- e) the responsibility of each Party;
- f) dissemination of results
- g) any other information that the Parties deem appropriate.

## ARTICLE 5 Financing

The Parties shall fund the cooperation activities herein referred to with the allocations from their respective budgets, depending on their availability, impact on the budget and the provisions of the applicable national law.

Each party shall bear the costs of participation, except that it is considered appropriate to use alternative funding mechanisms for specific activities or the Parties agree specific funding arrangements for specific activities.

## ARTICLE 6 Participation of other institutions

Parties, if deemed appropriate, will encourage the participation of other public or private institutions whose activities directly affect the areas of cooperation, in order to strengthen and expand mechanisms to support effective implementation of this Agreement.

## ARTICLE 7 Intellectual Property

If as a result of the cooperation activities developed under this Agreement, products of commercial value and/or intellectual property rights are generated, they shall be governed by the applicable national legislation and the international conventions in the matter, binding for the United Mexican States and India.

## ARTICLE 8 Exchange of Information

The Parties may exchange data, observations, reports, publications and any other documentation deemed necessary for the implementation of cooperation activities.

To disseminate the exchanged information due to cooperative activities, it must have prior written approval by the Party that provided the information. The information that is considered confidential shall not be disclosed.

## ARTICLE 9 Monitoring Mechanism

In order to achieve the best possible implementation conditions of this Agreement, the Parties shall appoint one representative each, who will coordinate the cooperation activities covered by this Agreement.

- By the University of Colima is appointed to the General Direction of International Relations and Academic Cooperation.

 By the Sagi Rama Krishnam Raju Engineering College is appointed to the Dean of International Affairs and Projects.

The coordinators will meet with the frequency and place agreed by the Parties, in order to evaluate the results derived from the application of this Agreement and shall be responsible for the following functions:

- a) grant the necessary decisions in order to achieve the objective of this Agreement;
- b) identify areas of common interest to develop and formulate the AOP's
- c) guide, organize and formulate appropriate recommendations for the implementation of the cooperative activities of this Agreement, and
- d) any other functions agreed by the Parties.

#### ARTICLE 10 Labor Relation

The staff assigned by each of the Parties to undertake cooperation activities shall continue under the direction of the institution to which they belong so will not create any labor relation with the other, which is not considered pattern or joint replacement.

## ARTICLE 11 Entry and Departure of Participants

The Parties shall facilitate before their corresponding authorities the entry, stay and departure of the participants officially involved in the cooperation activities under this Agreement. These participants shall abide by the immigration, tax, customs, health and national security provisions in force in the host country and shall not engage in any activity unrelated to their duties without the permission of the competent authorities. The participants shall leave the host country in accordance with the laws and provisions of such country.

## ARTICLE 12 Insurance

The Parties shall ensure that the participants involved in the cooperation activities have health insurance, personal injury and life, to the effect that, in the event of a loss resulting from its development, which deserves repair or compensation, it be covered by the corresponding insurance company.

## ARTICLE 13 Public Liability

The Parties will not have liability for damages caused as a result of unforeseeable circumstances or force majeure, work stoppages particularly academics or administrative on the

understanding that, once overcome those events, activities will resume in the form and terms determined by the Parties.

#### **ARTICLE 14** Other Instruments

The cooperation under this Agreement shall be without prejudice to the rights and obligations acquired by the Parties under other international agreements to which they are parties.
